INFORMATION ON THE PROCESSING OF PERSONAL DATA

DATA MODE AND FINALITY

1. We inform you that the data will be processed with the support of the following means:

For the following purposes:

LEGAL BASE

RETENTION PERIOD

4. *The data required for contractual and accounting purposes are kept for the time necessary to carry out the commercial and accounting relationship.*

RIGHTS OF THE PERSON

5. Under the European Regulation 679/2016 (GDPR) and the national legislation in force, the person may exercise the following rights in accordance with and within the limits of the current legislation:

- request confirmation of the existence of personal data concerning him (the person's right of access – Article 15 of Regulation 679/2016);
- know its origin;
- receive intelligible communication;
- have information about the logic, manner and purpose of the treatment;
- request updating, rectifying, integrating, deleting, anonymously transforming, blocking data processed in violation of the law, including those no longer necessary to pursue the purposes for which they were collected right to rectify and cancel – art. 16 and 17 of Regulation 679/2016);
- Right to restrict and/or object to the processing of data relating to it (Article 18 of Regulation 679/2016);
- right to withdraw;
- The right to make a complaint to the Control Authority (the person's right of access – Article 15 of Regulation 679/2016).
